  - There will be a study by the Public Works Commission to be submitted within 6 months.

## Lake Stewardship Plan

Goal of the lake stewardship plan:

"To encourage residents, other users, and the community to promote the long-term health and beauty of Palmerston Lake by following ecologically sound principles and practices"

- What we have accomplished so far:
  - Established a timeline of 3 years to complete the lake stewardship plan.
  - Created an action plan based on Mississippi Valley Conservation Authority (MVCA) and the Federation of Ontario Cottagers Association (FOCA) lake planning guidelines.
  - Met with representatives of the lake planning committee for Canonto lake
  - Made contact with the MVCA and North Frontenac Council.
  - Received support in the creation of a Lake Stewardship Plan by the North Frontenac Council.

#### Next Steps:

- Find a volunteer for communications officer.
- Canvas for more community involvement of not only residents with properties on the lake, but residents within the Ompah hamlet.
- Find volunteers to participate in research of each section of the lake stewardship plan (see next slide).

- The following are sections of the lake stewardship plan that we need community involvement and input with the research:
  - The physical and Natural Environment
  - The Biological Endowment
  - History of Settlement, Land Tenure and Development
  - Natural and Cultural Assets
  - Natural Resources
  - Residential Development
  - The Impact of Climate Change
  - Carrying Capacity

# Questions About The Lake Stewardship Plan?



#### Lake Stewardship


- Stewardship activities focus on projects directed at maintaining, improving and monitoring the quality of the water in Palmerston Lake.
- These activities involve social interaction
  - workshops, water quality testing, shoreline enhancement, tree planting, improving fish habitat
- getting together to work on a project.

- This season our actives centred around:
  - Initiating a response to the presence of Eurasian Water Milfoil in our lake
  - Locate EWM




- Initiating a response to the presence of Eurasian Water Milfoil in our lake:
  - Develop a 'whole of lake' approach to the management of Eurasian Water-Milfoil (EWM) in Palmerston Lake. EWM was observed in the lake starting the summer of 2019.
  - It is not widespread, Yet.
  - A critical part of this approach is locating and mapping occurrences of EWM.
  - This will help us decide on a course of action for each location.

- Locate EWM:
  - The lake will be partitioned into manageable zones, 1 to 6.
  - One volunteer from each section will act as zone steward, receiving information from others in that zone, passing that on to a PLA board member or the lake steward.
  - If you or someone you know would be able to do this, please send us an email.



- Developing a 'Build Smart, Lake Smart' Initiative
  - The Build Smart effort will help provide a framework for understanding how we can best build/renovate/innovate on our lake properties, within 30 metres of the water, in order to preserve and enhance water quality in the long run.
  - The Lake Smart effort will guide us in understanding the importance of why and how to protect that part of our properties that are within 15 metres of the water.
  - In particular the zone known as littoral zone.



- Introduction of Citizen Science Programs
  - This program, or combinations of activities, suited the pandemic environment. Addressing some of the following:
    - Whole family involvement
    - Drawing attention to our property and lake environment
    - Some science around elements that contribute to our mission to uphold water quality
    - We encourage you to pick a project and organize to carry it out next season
    - Send us an email and let us know what you plan to do. If you agree, we will create a section on the webpage to let others know
    - A link to these programs can be found on our web page under the Quick Links tab.

- Work on a 'Cottage Binder'
  - A coffee table book for family and guests. A guide for life on our lake.
  - Eventually and essentially, a book highlighting important information about the who, what, when, where and why of lake life, directed at protecting water quality.

- Water Quality
  - Based on Secchi depth and surface water total phosphorus results in 2019 (Table 9, Figure 15) the lake maintains an oligotrophic status.
  - The water temperature and dissolved oxygen profile data from the 2019 sampling events are available in Appendix A.
  - All good news.






**OEB orders Hydro One to eliminate the Seasonal Rate Class**On September 17, 2020, the **Ontario Energy Board (OEB)** ruled that Hydro One will eliminate the Seasonal Rate Class and shall move all customers into one of their other, density-based rate classes. This decision has been preceded by numerous rate applications and intervenor submissions by FOCA and others over the past five years.

FOCA remains extremely concerned about the financial impacts this change will have on the estimated 78,000 seasonal customers that will be moving to the R2 (low density) residential class and will face increases of \$60/month or more, based on Hydro One's last estimates. It has been a different summer at the lake. We were not able to get there until June. Some people were able to drive to and isolate, but we had to wait until marinas and ramps were available.
