Mary Rothfels reported on LOON SURVEY requests that members kindly report loon sightings. Report the maximum number of loons that you see at one sighting on the lake in each month of May June, July and August. eg "In June, I saw 1 loon every day and I saw 2 loons on several days, on one occasion I spotted 4 loons (2 adults and 2 chicks) together at one time". My report will say '4 loons' for the month of June; Apparently our lake could support 4 groups of 2 adults and 2 chicks.

Question from Doug Roberts regarding nesting sites; loons will nest in swampy areas; quiet; nest at water level in reeds; on a bit of shoreline – will see one or 2 eggs per nest; Doug Roberts asked where the biggest patch of Eurasian Milfoil is –off the north shore of Dabney's island; Question by Mary regarding whether people should report new patches? John V. encourages members to report; questions deferred to end of meeting today.
