


# Lake Management Plan

'Data For Light Not Heat'


- Long term 'living' project engaging our partners

# Committee Reports: Lake Stewardship Plan



## What is Lake Stewardship?

- Stewardship is an <u>activity</u> that focuses on:
  - responsible planning and management of resources.
- Palmerston Lake Stewardship focuses responsible planning and management on our greatest resource:
  - the quality of our lake water.

# How are we focusing on the quality of our lake water?

First we must ask the question...

What kind of a lake is Palmerston Lake?



### Palmerston Lake is an Oligotrophic lake

Oligotrophic lakes are generally clear, deep and free of weeds or large algae blooms. Though beautiful, they are low in nutrients and do not support large fish populations, However, oligotrophic lakes often develop a good food chain capable of sustaining a very desirable fishery of large game fish

### Facts about Oligotrophic lakes

- 1. Flora, fauna, aquatic life and waterfowl all flourish on oligotrophic lakes.
- 2. Any reduction in the numbers of any of the above can indicate negative changes in the quality of the lake water.
- 3. Any increase in the numbers of the above can indicate positive changes in the quality of the lake water.
- 4. Successful Stewardship activity has proven to increase the numbers of these types of organisms.


Collected at the deepest parts of the lake in 2 locations:

- South Basin = 8.59 metres







### Loons as Indicator

### Species Survival of Loon Chicks is Influenced by:

- Lake acidification
- Mercury poisoning
- Loss of habitat for nesting and fish spawning
- Water level changes from May to July
- Boat wake swamping nest or separating chicks from parents
- Predation
- Disturbance / harassment
- Lead poisoning from discarded fishing tackle
- Entanglement




- Top of food chain
- Long-lived species
- Biomagnification of pollutants and contaminants

### Eurasian Water Milfoil – What can we do together?

The presence of Eurasian Water Milfoil has been the focus of this activity

The takeaway from our work on this invasive species:

- Clear your shoreline (littoral zone) using hand harvesting technique(s)
- When on the water carry a net and if you see floating weeds, gather them, bring them home and dispose of them in the garbage
- Stay out of the weeds


